# TMA's Appeal to Cease Electricity Diversion from Taloja MIDC Feeder To External Areas

### Sub: Request to Cease Electricity Diversion from Taloja MIDC Feeder to External Areas

Respected Sir,

Taloja MIDC has over 850 industries, employing a workforce of approximately 200,000. We would like to bring to your attention an urgent matter concerning the electricity supply to our industrial area.


It has observed that electricity from the Taloja MIDC feeder is being transferred to areas outside the MIDC. This practice has resulted in frequent power disruptions and insufficient supply to our industries, which heavily rely on uninterrupted electricity for their operations. The ongoing disruptions have not only affected our production capabilities but also caused significant financial losses and operational challenges for our member industries.

We understand the necessity of maintaining a balanced power distribution; however, we strongly believe that the needs of the industries within Taloja MIDC must be prioritized to ensure our continued growth and contribution to the regional economy. Therefore, we kindly request that you take immediate action to halt the transfer of electricity from the Taloja MIDC feeder to outside areas.

We appreciate your attention to this matter and look forward to a favorable resolution that will support the continuous functioning of industries in Taloja MIDC.

The Taloja Manufacturers' Association (TMA) has formally addressed a critical concern regarding electricity supply in the Taloja MIDC area through a communication (Ref: TMA/RMP/24-25/62, dated 15.10.2024) to the Chief Engineer of Maharashtra State Electricity Distribution Co. Ltd. (MSEDCL). TMA highlighted that over 850 industries, employing nearly 200,000 workers, are facing significant operational challenges due to frequent power disruptions.

The disruptions stem from the diversion of electricity from the Taloja MIDC feeder to external areas, which has led to an inconsistent and insufficient power supply for the industrial zone. This situation has adversely impacted production and caused financial and operational difficulties for member industries.

Recognizing the necessity of balanced power distribution, TMA has emphasized that the needs of Taloja MIDC's industries must be prioritized to safeguard the economic contributions and growth of the region. TMA has urged MSEDCL to take immediate action to halt the diversion and ensure uninterrupted electricity supply.

TMA anticipates a positive response and swift action to support the continuous and efficient functioning of industries in Taloja MIDC, maintaining their vital role in the regional economy.

**Loan limit under Pradhan Mantri Mudra Yojana (PMMY) increased to Rs. 20 lakh from the current Rs.10 lakh**

- As announced by the Finance Minister on 23rd July, 2024 in the Union Budget 2024- 25, the limit of Mudra loans under the Pradhan Mantri Mudra Yojana (PMMY) has been enhanced from current Rs.10 lakh to Rs. 20 lakh.
- This increase aspires to further the overall objective of the Mudra Scheme which is Funding the Unfunded.
- As per the notification issued in this regard, the new category of Tarun Plus is for Loans above Rs.10 lakh and upto Rs. 20 lakh and would be available to the entrepreneurs who have availed and successfully repaid previous loans under the Tarun category.
- The guarantee coverage of PMMY loans upto Rs. 20 lakh will be provided under the Credit Guarantee Fund for Micro Units (CGFMU).

The Taloja Manufacturers' Association (TMA) has formally addressed the issue of truck parking in Taloja MIDC by submitting a request (Ref: TMA/SJS/24-25/61, dated 14.10.2024) to the Executive Engineer, MIDC. TMA highlighted that, despite the operational status of the new truck terminal, trucks continue to park on both sides of the interior roads. This practice obstructs pedestrian pathways and disrupts the smooth flow of traffic, leading to frequent traffic jams.

To mitigate this issue, the TMA has proposed the installation of "No Parking" boards on one side of the interior roads and on both sides of the main roads. This measure would serve as a deterrent for truck drivers, facilitating smoother traffic flow and enabling local police authorities to enforce parking regulations effectively.

This initiative aligns with the TMA's commitment to enhancing infrastructure and contributing to the "Smart City Taloja" program. TMA has also shared this request with the Chief Engineer (HQ) MIDC, Mumbai, the Superintending Engineer, MIDC Konkan Region, and the Deputy Commissioner of Police (Traffic), Navi Mumbai, to emphasize the importance of immediate action.
