The Taloja Manufacturers' Association (TMA) held a meeting on November 6, 2024, at 3:30 p.m. in the TMA Conference Hall to discuss the Property Tax Assessment Notices issued by Panvel Municipal Corporation (PMC). The meeting was chaired by Shri Shekhar Shringare, Hon. President of TMA, and attended by 60 representatives from various industries.

The aforementioned meeting was organised to review the status of the case filed before the Hon'ble High Court, Mumbai, concerning PMC's Property Tax Assessment Notices. Wherein, Advocate E.A. Sasi addressed numerous queries from members regarding the case. Valuable suggestions from members were noted for inclusion in Advocate Sasi's arguments during the proceedings.

#### **Additional Matters:**

Some industries reported receiving Local Body Tax (LBT) notices from PMC. Advocate Sasi, also handling the LBT case, was requested to draft a response letter for the notices. Accordingly, the draft was shared with members .

The meeting concluded with a vote of thanks to all attendees for their active participation and contributions.

## **Advisory on Updates to E-Way Bill and E-Invoice Systems**

The Goods and Services Tax Network (GSTN) has announced important updates to the E-Way Bill and E-Invoice systems, effective from January 1, 2025. These changes aim to enhance security and compliance. The key update is the mandatory implementation of Multi-Factor Authentication (MFA) for taxpayers with an Annual Aggregate Turnover (AATO) exceeding Rs 20 Crores, effective from January 2025. MFA will be extended to taxpayers with AATO exceeding Rs 5 Crores by February 2025 and to all taxpayers by April 2025. Additionally, starting January 2025, E-Way Bill generation will be restricted to documents dated within 180 days from the date of generation. Also, extensions for E- Way Bills will be limited to 360 days from the original generation date. Taxpayers are urged to activate MFA immediately and update their registered mobile numbers to comply with these changes.

## Government of India, States and Union Territories Advisory on Updates to E-Way Bill and E-Invoice Systems

GSTN is pleased to announce that NIC will be rolling out updated versions of the E-Way Bill and E-Invoice Systems effective from 1st January 2025. These updates are aimed at enhancing the security of the portals, in line with best practices and government guidelines.

#### 2. Multi-Factor Authentication (MFA):

One of the key changes involves the implementation of Multi-Factor Authentication (MFA). Currently, MFA, which requires login using a username, password, and OTP (sent to the registered mobile number, Sandes app, or similar platforms), is mandatory for taxpayers with an Annual Aggregate Turnover (AATO) exceeding Rs 100 Crores since 20th August 2023 and optional for those with AATO exceeding Rs 20 Crores since 11th September 2023.

- a) Starting 1st January 2025, MFA will become mandatory for taxpayers with AATO exceeding Rs 20 Crores, from 1st February 2025for those with AATO exceeding Rs 5 Crores, and from 1st April 2025 for all other taxpayers and users.
- b) Taxpayers are encouraged to activate and start using MFA immediately, and detailed instructions are available on the E-Invoice and E-Way Bill portals. It is advised to ensure that the registered mobile number is updated with your GSTIN.

#### 3. Restricting the period of EWB generation from the date of base document:

The generation of E-Way Bills will be restricted to documents dated within 180 days from the date of generation. For instance, documents dated earlier than 5th July 2024 will not be eligible for E-Way Bill generation starting 1st January 2025.

#### 4. Restricting the extension of EWB for specific time/period from the eWB generation date:

Furthermore, the extension of E-Way Bills will be limited to 360 days from their original date of generation. For example, an E-Way Bill generated on 1st January 2025 can only be extended up to 25th December 2025.

Taxpayers are requested to familiarize themselves with these updates and incorporate the necessary adjustments into their compliance processes. For additional details, please visit the respective portals.

# PF money can be withdrawn from ATM; know what is the new EPFO scheme You will get a separate ATM card for PF

Leaders Online Desk: The central government is now preparing to reform the system related to Provident Fund (EPFO). The government aims to increase services for EPFO members under the EPFO 3.0 initiative. According to reports, as part of this scheme, the Union Labour Ministry is considering increasing the contribution to the pension of employees and issuing ATM cards like debit cards. This will allow employees to withdraw money directly from 'ATM' in future. This scheme is likely to be implemented by May-June 2025. Currently, an EPF member has to wait for 7 to 10 days to withdraw his PF money. This time is taken after completing all the formalities of PF withdrawal and submitting the necessary documents to EPFO. This wastes more time. Currently, salaried employees contribute 12 percent of their earnings to their EPF account every month. Meanwhile, the employer contributes 3.67 percent to the EPF account. The remaining 8.33 percent is distributed to the Employees Pension Scheme (EPS). The employer also contributes 0.50 percent to the Employees Deposit Linked Insurance (EDLI) account of the employees.

#### Consideration to remove 12 percent limit on PF contribution

Meanwhile, according to media reports, the central government is considering removing the 12 percent cap on PF contributions made by employees. If this change is made, employees may get the option to contribute more based on their savings. However, the employer's contribution will remain unchanged.

#### What will be the impact on the pension amount?

According to reports, the limit on PF contribution of employees is likely to be removed. This change will not have any impact on the pension amount. As the pension contribution will also remain constant at 8.33 percent. The pension amount will increase only if the government increases the salary limit for PF deduction. Which is currently Rs 15,000. The central government is likely to increase this limit from Rs 15,000 to Rs 21,000.


