Merc announces power tariff changes, 10-30% reduction in charges from April

Nashik: MSEDCL, with the highest electricity tariff across the state, will see a 10-30% drop in rates for residential consumers from April 1, as per the latest order of the Maharashtra Electricity Re-Commission

The Merc's new multi-year tariff order, published on their website, marks an unprecedented decrease in electricity rates across all consumer categories. "Against the MSEDCL's projected revenue

Merc attributed the rate reduction to two key factors - MSEDCL's failure to curb distribution losses at 14% (actual losses were 22%) and the anticipated cost savings from future renewable energy generation

The Guidance Session by Shri. Ashok Rajput Asst. Commissioner of Police, Shri. Pravin Bhagat, Sr. P.I. (Incharge) Police Station, MIDC, Taloja & Team on Industry-Related Harassment & Fraud Issues held on 17.02.2025 at TMA Conference Hall.







A guidance session addressing industryrelated harassment and fraud issues was held on February 17, 2025, at the TMA Conference Hall. The session was graced by the presence of Shri. Ashok Rajput, Assistant Commissioner of Police, Shri. Pravin Bhagat, Senior Police Inspector (In-charge) of MIDC Taloja Police Station, and their team.

Shri. Shekhar Shringare, President of TMA, welcomed the esteemed officials by presenting a Tulsi plant as a token of respect and extended a warm welcome to the members present.

Shri. Pravin Bhagat, Sr. P.I. of Taloja Police Station, introduced himself and provided insights into the law and order situation in Taloja MIDC. He assured that the police would act as facilitators and encouraged industries to remain vigilant. He emphasized the importance of security measures, advising factories to ensure their security personnel have a contact list of key individuals for emergencies. Furthermore, he

highlighted the necessity of identifying and reporting illegal Bangladeshi and Nigerian workers to the police.

Shri. Ashok Rajput, ACP, elaborated on the Maharashtra Chief Minister's 100-day plan aimed at preventing industries from relocating to Gujarat due to harassment and fraud. He assured complete support from the police department and urged industries to install high-quality CCTV cameras at entry and exit points to deter criminal activities. Additionally, he stressed the importance of verifying security agencies before hiring them. He assured police intervention in union or Mathadi-related disputes through mediation meetings and agreed to arrange a meeting between labor contractors and the police, as requested by an industry representative.

Addressing Industry Concerns:

Harassment by locals for contracts or money: Shri. Ashok Rajput, ACP, instructed industries to submit written complaints to the police station for prompt action.

- **Mandatory helmet use:** The ACP appealed to industries to enforce helmet usage for employees commuting via two-wheelers.
- Hazardous effluent disposal: Hon. President, TMA, raised concerns about tankers illegally unloading hazardous effluents into chemical zone chambers. In response, the ACP instructed Sr. P.I. to take strict action.
- **Transport restrictions:** The Hon. President, TMA, reported that local transporters were preventing external transporters from operating in industries. The ACP directed the Sr. P.I. to address the issue.
- **Theft incidents:** An industry representative expressed concerns over frequent diesel theft from parked trucks in the engineering zone. The ACP instructed the Sr. P.I. to increase night patrolling in the area.

Expert Guidance:

- Shri. Shingate, Asst. P.I., provided guidance on cyber fraud prevention.
- Shri. Khairnar, Asst. P.I., educated industries on legal rights and responsibilities.
- Shri. Sitaram Satpute, spoke about job fair initiatives.

The session was attended by 50 industry representatives. Hon. President, TMA, concluded the meeting by urging all industry members to extend full cooperation to the police to ensure smooth industrial operations.





- S.O. 1364(E).—In exercise of the powers conferred by sub-section (1) read with sub-section (9) of section 7 and sub-section (2) read with sub-section (3) of section 8 of the 'Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006)', the Central Government after obtaining the recommendations of the Advisory Committee in this behalf hereby makes the following amendments in the notification of Government of India, Ministry of Micro, Small and Medium Enterprises number S.O. 2119 (E), dated the 26th June, 2020, published in the Gazette of India, Extraordinary, Part-II, Section 3, sub-section (ii), dated the 26th June, 2020, namely:-
- In the said notification in paragraph 1,—
- (i) in clause (i),-
 - (a) for the words "one crore", the words "two crore and fifty lakh" shall be substituted;
 - (b) for the words "five crore", the words" ten crore" shall be substituted;
- (ii) in clause (ii),-
 - (a) for the words "ten crore", the words "twenty five crore" shall be substituted;
 - (b) for the words "fifty crore", the words "one hundred crore" shall be substituted;
- (iii) in clause (iii),-
 - (a) for the words "fifty crore", the words "one hundred twenty five crore", shall be substituted;

Sub: Dual taxation on the industries of Taloja MIDC

Taloja MIDC industrial area which was established by MIDC as a nodal agency appointed by the government of Maharashtra with the intention of developing the industrial infrastructure of Taloja MIDC & subsequently collecting service charges, water charges, drainage charges, Streetlights, Roads, Common Effluent Treatment Plant, Fire services etc.

The industries in Taloja are under tremendous financial pressure and competitive pressure from the other states in India in terms of expensive electricity, labour, transportation, etc.

The Panvel Municipal Corp. (PMC) was established in 2016 wherein Taloja MIDC was also included within the jurisdiction of PMC wherein, they have started sending huge property tax bills against the nominal grampanchat tax which the industries were paying earlier

The property tax bills raised by PMC is 100% to 200% more than the grampanchayat tax, though PMC is not providing any services like water supply, drainage, roads, streetlights,Common Effluent Treatment Plant, Fire services, etc.

The industries in Taloja MIDC area faced with such huge financial implications on their profit margins, will not be favorable to operate their industries from Taloja MIDC and would rather shift to the neighbouring states with industrial with friendly policies.

Update on Streetlight issues in Taloja MIDC

Attention is invited to GST Amnesty Scheme 2024 notified by the Central Board of Indirect Taxes and Customs (CBIC), New Delhi.

- 2. In this connection, it is to inform that Central Board of Indirect Taxes and Customs (CBIC) has introduced GST Amnesty Scheme 2024 under section 128A of the CGST Act 2017. This scheme aims to provide relief to taxpayers by waiving interest and penalties associated with tax demands under Section 73 for FYs 2017-18, 2018-19 and 2019-20 provided full amount of the outstanding tax demand is paid by March 31, 2025. Further, cases where a notice was initially issued under section 74 for FYs 2017-18, 2018-19 and 2019-20, and an order is passed or required to be passed by the proper officer under section 73 (in pursuance of the direction of the Appellate Authority or Appellate Tribunal or a court in accordance with the provisions of sub-section (2) of section 75) are also covered under the scheme for the purpose of waiver of interest or penalty or both. The taxpayer must file an application electronically using FORM GST SPL-01 or GST SPL-02 depending on their specific case.
- If an appeal or Writ Petition is pending against the notice or order under section 73, taxpayer is required to withdraw such appeals before applying for the waiver.
- 4. For further details Section 128A of the CGST Act, 2017, Notification No. 21/2024-Central Tax dated 08.10.2024 (https://taxinformation.cbic.gov.in/view-pdf/1010186/ENG/Notifications) and Circular No. 238/32/2024-GST dated 08.10.2024 (https://cbic-gst.gov.in/pdf/circular-238-32-2024-GST.pdf) may be referred.
- 5. The Trade and Industry Associations/Chamber of Commerce are therefore requested to bring the above scheme to the notice of all their members so that they can take maximum benefit of the scheme to bring down their litigation in GST cases.
